TERMS AND CONDITIONS

I understand that:

1. The Membership Year runs from 1 July to 30 June each year and that I am committing to membership for the duration of the Membership Year in the category I have nominated.
2. I am liable for the full payment of this membership including any fees and charges as stated on my Invoice, and as prescribed by the Club.
3. Should I forfeit a payment, the Club will endeavor to contact me to settle the debt on the details I have provided.
4. The Club has the right to be paid the total amount owing plus any associated costs incurred to settle the account.
5. Should I default upon payment my membership shall be cancelled and that any monies, vouchers or prizes allocated to me shall be forfeited to the Club.
6. By participating in an installments form of membership payment, I shall have the same rights and privileges as any member in the category in which I have elected to join or renew, provided I am abiding by the Terms & Conditions for Installment Payments.

Pension Rate Requirements

"The pension rate will apply to those members on full or part aged, disability or veteran's pension once they have been golf members of Morisset Country Club at the full relative rate for 10 continuous years"

OR

"To new or current members who are able to produce Centrelink "AGED PENSION INCOME STATEMENT" for verification that they are on the full aged, disability or veteran's pension ie. The pension is their ONLY source of income, regardless of previous membership term"
